Sub: Recognition of School upto Middle level (I to VIII) with
effect from the academic session 1998-99(un-aided).

Sir,

With reference to your application on the subject cited
above I am directed to convey the approval of Director of Education
for the recognition of the school upto Middle level without aid
w.e.f. 1998-99 academic session subject to the following terms
and conditions:-

- 1) That the school shall admit students without any discrimination of caste and creed.
- 2) That a proper library be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of books 10 books per student shall be purchased and made available to the students.
- 3) That adequate sports materials shall be purchased and made available to the students.
- 4) That the school shall strictly not run any unauthorised classes or any other activities within the school premises and all the unrecognised classes immediately, if any, discontinued immediately.
- 5) That the school shall strictly abide by the provision of Section 10(1) of DSEA 1973.
- 6) That the school shall dispense with the service of unqualified and overaged staff, if any, immediately and appoint qualified staff.
- 7) That the service contract between the management and the employees be revised as per DESR-1973 immediately.
- 8) The Management Committee shall regulate the functioning of school strictly in accordance with the provision of DESR & Rules 1973.
- 9) Managing Committee of the School shall not increase fee in future academic session without prior approval of Director of Education which is mandatory requirement under sub-section (3) of Section-17 of DESR & Rules 1973.
- 10) That all the facilities prescribed under rule 50 and 51 of DESR & Rules, 1973 shall be made available to the students.
- 11) That the arrangement for good drinking water shall be made available to all the student as well as the teachers and the sanitary facilities shall also be provided to the students.

- 12) That the staff has paid all arrears due as per fifth pay commission. Proof be given to EO/DEO for verification.
- 13) Medical facilities/leave, LTC, Bonus, teaching allowances, GPF etc. be paid to the staff of the school.
- 14) Provident fund, register be maintained and cash book be completed and shown to EO of the Zone concerned for verification from time to time.
- 15) That the violation of any instruction/conditions/rules and regulation of the Department shall lead to the withdrawal of recognition of the school.
- 16) That the Science Lab. have to be improved/renovated by the school.
- 17) That the Management of the school shall create a reserve fund of the tune of three months salary of the staff of the school in the joint name of the DDE(S) and the Manager of the school.
- 18) That the school shall restrict the enrolment in every class at the ratio of 10 Sq. ft. per student.
- 19) That the school will co-operate with the Deptt. to work for EFA activities. The school will approach the Distt. Office in connection with EFA activities.
- 20) That the school will give proof of withdrawal of recognition from MCD.
